Clinical Negligence

Erica acts for both patients and practitioners in all areas of clinical negligence including spinal and brain injury, negligent surgery and post-operative complications, obstetric and gynaecological negligence, misprescription of drugs and plastic surgery. Product Liability

Erica's practice encompasses all types of product liability including group actions in relation to pharmaceutical and medical products.
