  - Representing a railway industry contractor in relation to the inquest into the death of a possession support worker who was killed on the track during planned engineering works.
  - Representing a university in relation to the inquest into the death of one of its students.
  - Instructed on behalf of the Managing Director of a care home who was prosecuted following a fire in which two residents died.
